



## Haiti Adoption Program Fee Schedule

Below is a list of standardized fees incurred in the adoption of a child from Haiti.

**1. All Blessings International, Inc. Agency Fees:..... \$6,100.00**

- \$50 Preliminary Application Fee
- \$200 Formal Application Fee
- \$750 First Agency Fee due with submission of Agency Business Agreement
- \$2350 Second Agency Fee due with submission of Dossier
- \$2750 Third Agency Fee due upon exit from IBESR

**2. Home Study & Post-placement Fees: ..... \$1,200.00 - \$3,000.00**

Home study and post-placement service fees are determined by the agency you choose and are paid directly to that provider. The fees above are an estimate only. ABI can provide home study and post-placement services to families residing in Kentucky & Missouri. Please call or email us to request a Guide to Services, which will provide more detailed information about the services and fees for ABI.

**3. Post-Placement/Post-Adoption Monitoring Fee .....\$1000**

This fee is paid to ABI at the time of exit from IBESR and is to cover post-placement/post-adoption monitoring, shipping of reports after the adoption and any translations of reports after the adoption if needed.

**4. Adoption Education ..... \$200**

This fee is paid to Adoption Training Program, as 12 hours of education are required.

**5. Dossier Translation & Legalization Expenses: ..... \$700 - \$1150**

Family will pay for actual authentication expenses. ABI will collect and wire translations fees to translator. Families are not billed for shipping of documents.

**6. USCIS Fees & Fingerprinting: .....\$720.00 Form Fee**

**.....Fingerprinting Per Person: \$85.00**

Citizenship and Immigration Services charges \$720 to process the I-600A. This check is made payable to USCIS and sent with the I-600A application. Please note: CIS charges an additional \$720 for a second, unrelated child. This is payable to the US Embassy in Haiti. Citizenship and Immigration Services charges \$85 per person for fingerprinting. This check is made payable to USCIS and sent with the I-600A application.

**7. International Fees:.....\$14,000**

- Due upon acceptance of referral. Fee covers adoptions processing in Haiti and child care expenses. \$6250 is immediately sent to Haiti for case processing. \$6250 is held in escrow and is sent to Haiti upon exit from IBESR. Should Haiti officially close for adoptions and a case not have exited from IBESR family may receive \$6250 back. \$1500 is applied toward international trips for ABI staff to visit the children and orphanages, shipping & communication costs, and unexpected expenses or emergencies encountered in serving Haitian children.

**Please note: No part of the International fee is refundable unless otherwise specified! It is impossible to predict the length of processing time for adoptions!**

**8. DNA Testing Fee: .....\$350.00 - \$500.00**

On occasion DNA testing is requested. This fee is payable via credit card directly to the lab.

**9. Visa Costs ..... \$400 per child**

Payable at Visa appointment.

***\*PLEASE NOTE: All fees are subject to change and any fees not paid to ABI are not under the control or discretion of ABI. All fees paid to ABI are considered fees for services and are not refundable.***

- Travel expenses for one or both parents and the child are in addition to the above fees.
- All fees listed are in U.S. currency and subject to change.
